## NATIONAL BRIEFING

I am super excited to share the historical results of this year's NATA Joint Committee Board of Directors Meetings. After a year of discussion, presentations at each of the District symposiums and thorough review of our Bylaws, I am excited to let you know that we approved the request brought forth by District 4 to split thereby creating a new District 11. This request by the states of District 4 was brought forth in part because of limited membership service opportunities that exist when a District of 9,000 plus members are allowed the same national participation in committees and voice as a district of 2,000 members. Bylaw 5.2 allows for a district that represents 20% of the national membership to split if the request is brought forth by the states. After listening to our state leadership feedback and spending much time researching the Bylaws I am confident this is the correct choice. Look for the implementation of **District 11 January 2021**.

I am also honored to have participated in the NATA Presidential Nomination Committee where two final candidates were selected from a pool of four. This is the first time two women will run for office. Both **Kathy Dieringer** and **Katie Walsh Flanagan** will serve our profession well.
